Health Officer Update

Mark Larson M.D. stepped to the microphone and updated the board on the current unvaccinated resident in Ellensburg who has been exposed to Measles while traveling overseas. Dr. Larson discussed the role public health plays and the work that goes into one potential exposure and the outside resources that are necessary. There was some discussion about measles, quarantine, and vaccination rates at the college.

Wildfire Smoke Impacts Workgroup Update

Mark Larson M.D. presented to the board information from the Wildfire Smoke Workgroup. Dr. Larson presented information about PM2.5 during the wildfires of previous years and discussed air quality around fair time last year. Dr. Larson discussed the potential for future impacts due to air quality and that the Wildfire Smoke Impact Workgroup, that includes people from Department of Ecology, Washington

State DOH, Oregon Health Sciences, people from California who deal with wildfires, local public health departments, Spokane, and King County. We know that wildfires are getting worse. Dr. Larson discussed multiple closures around the county and the health impacts that affect our community. The Wildfire Smoke Impact Workgroup is focusing on guidance for air quality problems and objectives. The three main objectives are communication that is consistent across the state, provide school closure and event cancelation procedures, and discuss what we can do with low cost sensors. Closures due to air quality are going to come from the local health departments. The group had decided last week using PM2.5 to consider closing at 35.5 and require closing at 80.5. Dr. Larson discussed the health risks of being out in wildfire smoke, and discussed the future of how to approach discussions with those that will be effected by bad air quality, and closures that may need to happen. Dr. Larson will keep the board posted of further updates from the group and this will be an ongoing discussion.
