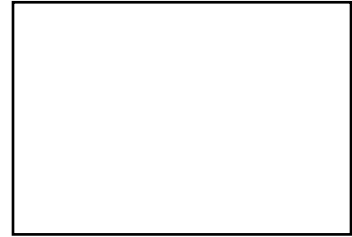

**Prior to issuance of a building move permit, the following items must be completed pursuant to Kittitas County Code 5.16 House and Building Moves:**

- Applicant will submit a bond in the amount as determined by the Kittitas County Engineer on account of any damages the county might suffer as the result of the exercise of such permit, and on account of any expense the county may be caused in removing or replacing any of its signs, delineators, bridge railings, or any other county property or facilities to accommodate the moving of any building or over legal load along or across the county roads, streets, alleys, and bridges involved: said bond shall be kept on file with the department of public works until the following has occurred:
  - House mover has completed said move and the county engineer has determined that no damage has been caused by the house mover to the road, utilities, mailboxes, or other facilities along the route used
  - The bond shall be held for 10 days from date of compliance pursuant to KCC 5.16.070.
- A certificate of insurance to cover public liability and property damage in the following amounts:
  - 1) Five thousand dollars for property damage;
  - 2) Ten thousand dollars for a single injury or death;
  - 3) Twenty thousand dollars for multiple injuries or deaths, any of which might be caused by the permittee while engaged in such business as a house mover.

- Traffic Control Plan
- Axle Load Data / Special Motor Vehicle Permit
- Projected Load Count
- Proposed Schedule
- Pre/Post haul structural analysis of bridge & culvert structures by WA licensed Structural Engineer
- Liability Insurance Accord
