At approximately 4:00 p.m. **CHAIRMAN BOWEN** opened a public hearing to consider requests for Reclassification as Open Space Land for Current Use Tax Assessment Under the Open Space Taxation act from Brad Albertson/Miki Shigeto; Melissa Becker, and Andrew Fortier, etux.

MEGAN CALAIS, DEPUTY CLERK OF THE BOARD gave a staff report on the three separate Open Space Timber Applications. She reviewed each application noting the parcel numbers, application fee and Forest Management Plans.

THOSE PRESENT & TESTIFYING: PHILL HESS, CONSULTING FORESTER representing all three applicants spoke in favor of the requests. He said they all qualify for Open Space Timber according to RCW (primary use for growing and harvesting timber for commercial purposes) and Kittitas County Commissioner Resolution Number 2002-99. **THERE BEING NO ADDITIONAL TESTIMONY THE PUBLIC PORTION OF THE HEARING WAS CLOSED.**
