At approximately 6:00 p.m. **CHAIRMAN BOWEN** opened the continued public hearing to consider the Kittitas Valley Wind Power Project.

**CHAIRMAN BOWEN, COMMISSIONER CRANKOVICH and COMMISSIONER HUSTON** made disclosures. There were no objections made and all Board members remained seated.

**DARRYL PIERCY, DIRECTOR OF COMMUNITY DEVELOPMENT SERVICES** said the Board had been presented a draft Resolution, as directed at the prior public hearing.

**COMMISSIONER HUSTON** moved to approve Resolution No. 2006-90, Denying the Kittitas Valley Wind Power Project Proposal Including Denial of the Subarea Designation, Rezone Overlay, Development Agreement and Development Agreement Activities Permit. **COMMISSIONER CRANKOVICH** seconded.

**COMMISSIONER HUSTON** felt the Resolution captured the details specific to the shortcomings leading to the denial of the project. **COMMISSIONER CRANKOVICH** said the Resolution covered all of the discussions by the Board. **CHAIRMAN BOWEN** thought the Resolution was consistent with the record.

Motion carried 3-0.

**COMMISSIONER CRANKOVICH** moved to close the public hearing. **COMMISSIONER HUSTON** seconded. Motion carried 3-0.
