PUBLIC HEALTH

At approximately 11:00 a.m. **CHAIRMAN CRANKOVICH** opened a joint Public Hearing between the Board of County Commissioners and the Board of Health to consider a revision of the Public Health Departments 2007 Fee Schedule for a proposed increase in vital records and oral health fees.

CATHY BAMBRICK, PUBLIC HEALTH ADMINISTRATOR gave a staff report explaining that the Kittitas County Public Health Department is requesting revisions to the 2007 Fee Schedule for an increase in the vital records fee, in addition of a new oral health fee for fluoride varnish application and oral health education; rounding of Environmental Health fees; and changing of the verbiage related to mid-year increases in Public Health fees by the Administrator. She reviewed the history of the fee schedule between both the County and the State. She referenced new mandates that are being imposed on the County's Health Departments, noting most are of them are unfunded mandates.
