SPECIAL MEETING HOTEL MOTEL TAX DISBURSMENT COMMISSIONERS

At approximately 10:07 a.m. **CHAIRMAN** Alan Crankovich opened a continued special meeting from January 7, 2009 to review applications for the Hotel Motel Tax fund disbursement. He indicated that the Board had continued the meeting last week due to extreme weather conditions. He indicated that staff made contact with the applicants who were not in attendance last week and out of the three all but one was in attendance today.

The Commissioners went through the list and ranked the requests on how much they contribute to bringing in attendance to local business & tourism. They also looked at if projects needed all funding requested or if they could manage with just a portion. After careful consideration, the funds were preliminarily distributed as follows:
