TOPIC:	Department of Corrections Space Request
DISCUSSION:	Michael indicated that he had received an e-mail from Commissioner McClain explaining that the Department of Corrections (DOC) is looking for space for 3 DOC members. He explained that they needed two office spaces and space for reception and a conference room. Michael explained that he returned a call to Ralph Burthorn with DOC and got more information regarding their needs. He also questioned where we would relocate our staff and was unsure that was fair to keep moving them to accommodate DOC. Commissioner McClain explained that by moving DOC over to the Morris Sorenson building, as well as Juvenile Probation, it would allow for all probation services to be in one location and he felt that would be a benefit to their clientele. TOPIC:	Request for Temporary Employees – Swine Flu Temporary Funding
DISCUSSION:	Cathy indicated that the Federal Government is releasing funds relating to the H1N1 swine flu, to provide temporary staffing. She reviewed what the temporary staff would be responsible for and explained that if the flu gets as bad as it is suppose to be, and the way her current staff is, they could not do everything to provide the level of service needed to handle this.
