2011 BUDGET

Judy Pless, Budget & Finance Manager said at the conclusion of the last meeting the budget shortfall of the General Fund was \$376,305.00. She went over the budget reductions that had been made from various departments since the last meeting, as well as unemployment comp calculation. She said she went over wage calculations and said if everyone's wages were frozen, including the Union's it would be a total savings of \$235,576.93.

Commissioner Crankovich recommended reducing the contribution to the Regional Library Board by 20% which would be \$25,000.00.


Marsha Weyand, Assessor explained how the parcels have increased over the past few years and the importance of new construction and its effects on property taxes. She said they have been

behind with notices going out since 2003. She indicated notices should have gone out in May and they still not gone out yet. There was discussion of the Public Works funds and how the money can be spent. At the end of the meeting between reductions made by departments, along with a wage freeze for all employees, there was a fund balance of \$10,984.00. The Board indicated the Unions should get back to them by November 15th on the issue relating a wage freeze. If the Unions are not in favor of a wage freeze, it would be evident that a reduction in staff would be necessary.


