

## **Instructions for Form A:**

### **Adequate Water Supply Determination Form for Group A Community Water Systems**

#### **(READ ALL OF THE FOLLOWING BEFORE PROCEEDING)**

**Please be advised that Kittitas County Public Health Department typically takes 10 business days to process water availability applications. Do not expect same-day service, approval, and building permit issuance. If additional information is needed or there is missing information, the application will not be considered complete and will not be processed. Incomplete applications will be returned to the applicant after thirty (30) days.**

**Approval by KCPHD does not guarantee that an applicant has the legal right to a connection or use of ground waters of the State of Washington. KCPHD only approves applications based on water quality, quantity, availability, location, storage, and design aspects. KCPHD does not make determinations regarding an applicant's legal right to ground water or the validity of WAC 173-539A nor does KCPHD have the authority to perform such actions.**

#### **PLEASE COMPLETE OR PROVIDE THE FOLLOWING ITEMS:**

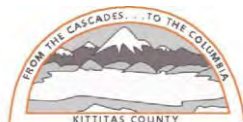
- The water system purveyor (manager) from the water system serving your home must complete Form A: Adequate Water Supply Determination - **Page 1**.

- Attach a current operating permit from Washington State Department of Health that is in green status.

- Mail, fax or deliver your completed application and required documents to Kittitas County Public Health Department. There is a **\$140.00 fee** associated with this application process.
