STATE ENVIRONMENTAL POLICY ACT ENVIRONMENTAL CHECKLIST

Purpose of checklist:

The State Environmental Policy Act (SEPA), chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of a proposal before making decisions. An environmental impact statement (EIS) must be prepared for all proposals with probable significant adverse impacts on the quality of the environment. The purpose of this checklist is to provide information to help you and the agency identify impacts from your proposal (and to reduce or avoid impacts from the proposal, if it can be done) and to help the agency decide whether an EIS is required.

Instructions for applicants:

This environmental checklist asks you to describe some basic information about your proposal. Governmental agencies use this checklist to determine whether the environmental impacts of your proposal are significant, requiring preparation of an EIS. Answer the questions briefly, with the most precise information known, or give the best description you can.

You must answer each question accurately and carefully, to the best of your knowledge. In most cases, you should be able to answer the questions from your own observations or project plans without the need to hire experts. If you really do not know the answer, or if a question does not apply to your proposal, write "do not know" or "does not apply." Complete answers to the questions now may avoid unnecessary delays later.

Some questions ask about governmental regulations, such as zoning, shoreline, and landmark designations. Answer these questions if you can. If you have problems, the governmental agencies can assist you.

The checklist questions apply to all parts of your proposal, even if you plan to do them over a period of time or on different parcels of land. D. SUPPLEMENTAL SHEET FOR NONPROJECT ACTIONS

No significant increase in discharge to water, emissions to air, production, storage or release of toxic or hazardous substances or production of noise should result from the implementation of this update. The proposed update doesn't include new uses that would result in a significant increase.

The proposal does include stricter environmental consideration for future private road construction projects. These additional considerations will serve to decrease discharge to water through more stringent stormwater requirements.

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

The update is not likely to affect plants, animals, or marine life over what already occurs under current County Regulations. The proposed update doesn't include new uses or changes that would result in a significant increase of the before mentioned items.

The proposal does include stricter environmental consideration for future private road construction projects. These additional considerations will serve to decrease discharge to water through more stringent stormwater requirements and encourage more consultation with Washington Department of Fish and Wildlife during bridge construction and reconstruction projects.

3. How would the proposal be likely to deplete energy or natural resources?

The proposal is not likely to deplete energy or natural resources because the road standards do not regulate the location or type of development activities. The Kittitas County Zoning Code regulates the location and type of development throughout the County. These standards ensure safe access to property with land use development activities.

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

Under RCW 36.70A, the Growth Management Act, the County has developed and implemented Kittitas County Code Title 17A, Critical Areas, which addresses development within or in the vicinity to wetlands, frequently flooded areas, geologic hazard areas, typed waters and wildlife habitat areas. Contained within the Kittitas County Code are regulations to address natural resource lands and the protection of agricultural and forest lands and activities.

The proposal is not likely to deplete energy or natural resources because the road standards do not regulate the location or type of development activities. These standards ensure safe access to property with land use development activities.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The proposed Development Code Update doesn't propose any additional shoreline uses. The Kittitas County Shoreline Master Program, Kittitas County Code Chapter 14.08, Flood Damage Prevention, and Kittitas County Code Title 17A, Critical Areas, will continue to govern shoreline proposals, and proposals will be reviewed and potential impacts will be addressed during the review period.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

No significant increases in demands on transportation or public services and utilities will result in the implementation of this update. The update requires land use development activities to evaluate concurrency as required by the Growth management Act. Projects that impact transportation demands will be required to mitigate for their increased demands.

The proposal does include stricter environmental consideration for future private road construction projects. A purpose of the update is to ensure consistency with local, state and federal laws and requirements.
