PUBLIC HEARING

SMOKING IN PUBLIC PLACES

COMMISSIONERS

Immediately following the Board of Health hearings, Chairman Crankovich opened a public hearing at 10:35 a.m. to consider the Board of Health's recommendation on adopting an Ordinance regarding Smoking in Public Places.

During the Board of Health public hearing, **CATHY BAMBRICK, PUBLIC HEALTH ADMINISTRATOR**, reviewed the proposed changes which would add language to further define a public place to include where tobacco is sold. She said by including that in the definition, private clubs would be incorporated into the definition, where the Kittitas County Public Health Department has experienced difficulty with enforcement. Ms. Bambrick noted the language is no more than what State law allows and now will be included in County Code.

CHAIRMAN CRANKOVICH noted that Ms. Bambrick had given a Staff Report during the Board of Health portion of the hearing.

THERE BEING NO ONE REQUESTING TO TESTIFY, THE PUBLIC PORTION OF THE HEARING WAS CLOSED.

At 10:36 a.m. Chairman Crankovich opened a public hearing to consider a fee schedule for the Kittitas County Public Health department.

During the Board of Health Public Hearing, Cathy Bambrick, Public Health Administrator, had reviewed a proposed fee schedule which does not exceed the actual cost of providing the services for which the fees are charged.

CHAIRMAN CRANKOVICH noted Ms. Bambrick had given a complete staff report during the Board of Health public hearing. COMMISSIONER McCLAIN noted he opposed the position the County is currently in with the Department of Ecology and the fees for the Hydro geological report reviews as defined by the Memorandum of Agreement. CHAIRMAN CRANKOVICH noted although he understood Commissioner McClain's opposition, there were other fees in the schedule which needed to be addressed as well.




RESOLUTION 2009-93 PUBLIC HEALTH FEE SCHEDULE COMMISSIONERS
