At 2:00 p.m. **Chairman McClain** opened a special meeting to discuss quarterly finances. He said he appreciated Judy Pless putting together this information.

Judy Pless, Budget and Finance Manager, showed a Power Point presentation showing the financial position of the County. She showed how the Preliminary Fund Balance from 2009 was \$68,675.03. She showed the 2010 Expenses and Revenues. She said the Retail Sales and Use Taxes graph looks alarming, but the County budgeted for that drop. **Vice-Chairman Jewell** asked about the 2 month delay for sales tax. **Ms. Pless** said that was normal. She said the cash balance was equal to 2005.

Deanna Panattoni, Treasurer said the interest rates are still low but there is a 16% increase in Real Estate Excise Tax (REET) collections. **Judy Pless** asked if there were any other obligations

under REET. **Vice-Chairman Jewell** said there was \$50,000 to the Upper County Ball Fields in Cle Elum, \$150,000 for parking lots and \$1.3 million for the Jail Mechanical Repair project.

Kirk Holmes, Public Works Director noted that the building permits are also busier than last year.


The meeting was adjourned at 3:45 p.m.
