Vice-Chairman Jewell said he had intended to give the Board updates on meetings with the Department of Ecology (DOE), Yakama Nation and Roza Irrigation District as well as DOE's suggestions. He said he wanted to generally talk about what the County wanted to do but they had run out of time.

Vice-Chairman Jewell moved to continue the special meeting to June 7, 2010 at 3:30 p.m. in the Conference Room. Commissioner Crankovich seconded the motion. The motion was amended to 10:30 a.m. June 7, 2010 with the agreement of all concerned. Motion carried, 3-0.

The meeting was adjourned at 5:00 p.m.
