Vice-Chairman Crankovich moved to approve and sign Ordinance 2011-006 Amending Title 13 Water and Sewer. **Commissioner O'Brien** seconded the motion. Motion carried, 3-0.

PUBLIC HEARING

STOP SIGN ON COYOTE RD

PUBLIC WORKS

At 2:20 p.m. **Chairman Jewell** opened a public hearing to consider amendments of Kittitas County Code Title 10 and placing a stop sign at the intersection of Coyote RD and Upper Badger Pocket RD.

Jan Ollivier, Transportation Manager, said they are asking to replace a yield sign with a stop sign, as the trees along Coyote RD have grown to obscure the oncoming traffic on Upper Badger Pocket RD. She said this was a safety issue.

Vice-Chairman Crankovich moved to approve Ordinance 2011-007 Amending Kittitas County Code Chapter 10.12.010(1) and 10.12.010(2) and placing a stop sign on Coyote RD at the intersection with Upper Badger Pocket RD. **Commissioner O'Brien** seconded the motion. Motion carried, 3-0.

PUBLIC HEARING AMEND KCC CH 10 RENAMING ROADS PUBLIC WORKS

At 2:25 p.m. **Chairman Jewell** opened a public hearing to consider renaming a portion of Vantage Highway to Main St, Sanders RD to Brick RD, and South Cle Elum Road to South Cle Elum Way and amend Kittitas County Code Sections 10.08 and 10.12.

Jan Ollivier, Transportation Manager, explained that the changes will be only to the road log and the code as the addresses of people living on these roads is consistent with the changes and has been for a number of years but the road log has been wrong. She said nothing will change for those people.

THE PUBLIC TESTIMONY WAS OPENED.

Len Williams, 2217 Brick RD, said his family had lived on Brick RD for thirty seven years and did not want the street name changed. He said the street sign at Game Farm RD had always said Brick RD until recently when it was changed to Brick RD (to the left) and Sanders RD (to the right). **Ms. Ollivier** explained that the actual road names and the addresses will not be changed.

PUBLIC TESTIMONY WAS CLOSED.


ORDINANCE 2011-008 AMEND KCC 10.08 AND 10.12 PUBLIC WORKS

Motion carried, 3-0.
