YRBWEP WORK GROUP

Commissioner Jewell presented a letter addressed to the YRBWEP work group. He reviewed the background of why the letter was being sent and to who. Commissioner O'Brien moved to approve Board signature on a letter of support for the designation of National Recreation Areas (NRA) as proposed in the Targeted Watershed Protections and Enhancements element of the integrated Water Resources Management Plan (IWRMP) for the Yakima River Basin.
