Commissioner Jewell moved to approve Ordinance No. 2013-001, approving the revisions of Kittitas County Comprehensive Plan and Titles 15A, 16 and 17 of the Kittitas County Code for the purpose of Compliance with Order Number 07-1-0004c and Number 07-1-0015 of the Eastern Washington Growth Management Hearings Board, noting that the amendments discussed at today's meeting would be incorporated prior to signing. Commissioner Berndt seconded. Commissioner Jewell thanked County staff for their time and involvement in this process as well as the attention from the citizens and their involvement. Commissioner O'Brien thanked staff and stated that the County will address the water portion of the Comp Plan at a later date, and that this document will be going to the Eastern Washington Growth Management Hearings Board (EWGMHB) for their consideration. Commissioner Berndt thanked staff for their time and patience and assistance with getting him up to speed. He thanked the citizens for their


