MICHELL SCHMIDT/NOISE WAIVER

COMMISSIONERS

Commissioner Jewell moved to approve a request for a waiver to the County Noise Ordinance from Michell Schmidt to hold a wedding at her residence on 9/7/2013 300 Mission View Drive, Ellensburg, WA 98926 until 12:00 a.m. 2013 (9/8/2013), noting that she was to notify her neighbors within 500 feet of her home and provide that notice to the

Board of County Commissioners Office no later than 9/6/2013.
Chairman Berndt seconded. Motion carried 3-0.
