SHORELINE MASTER PLAN

COMMISSIONERS

At 6:00 p.m. **Chairman Jewell** opened a continued Public Hearing from September 16, 2014, to consider updates to the Kittitas County Shoreline Master Program (SMP) as required within RCW 90.58.

CHAIRMAN JEWELL stated that Staff provided a full presentation at the initial Public Hearing on September 16, 2014. He stated that there were no new members of the public in attendance and therefore Staff would not go over the full presentation again. He questioned if there had been any changes or updates since the last meeting.

ANNA NELSON, PLANNING CONSULTANT stated that there were a few updates and additional slides added since the previous Public Hearing and reviewed the changes. She stated that there had been additional citizen comments submitted to the record.

THOSE PRESENT & TESTIFYING: MARK TESKE, DEPARTMENT OF FISH AND WILDLIFE (DFW) thanked County Staff for incorporating the suggestions that (DFW) has provided. He stated most of them have been included in the SMP Draft. He expressed concerns on page 62 in the draft regarding single family residence and page 77 regarding hazard tree removal.
