#### LEASE OF WATER

PUBLIC WORKS

At 1:00 p.m. CHAIRMAN WRIGHT opened a Public Hearing to consider the Leasing of Kittitas County Water Rights through Public Auction.

MARK COOK, PUBLIC WORKS DIRECTOR/INTERIM ENGINEER reviewed a proposed short term water lease program in response to the 2019 drought conditions. The proposal was to lease 25 acre-feet blocks of certain County owned water through an auction process. He said they were anxious to see if there was a market for it. The program would be somewhat of a test as there nothing similar within the State. He said the minimum bid would be \$240.00 per acre foot and an auction would be set for July 9, 2019 at 10:00 a.m. **PETER DYKSTRA, SPECIAL DEPUTY PROSECUTOR** answered questions from the Board and provided clarification of the proposed short term water lease program.
