Arden Thomas briefed the Board of County Commissioners on the progress of implementing the Multi-Jurisdictional Hazard Mitigation Plan. Arden Thomas stated that highlights include land acquisitions, multiple stream monitors for flow, upgrades to Snoqualmie Pass Utility District wastewater treatment and the planning phase of an additional reservoir.
