# REQUEST TO APPROVE MEMORANDUM OF UNDERSTANDING BETWEEN KITTITAS COUNTY AND LOCAL 792-CH (COURTHOUSE) TO ACKNOWLEDGE CREATION OF NEW POSITION – FISCAL/TECHNOLOGY SPECIALIST

Interim HR Director Killgore presented the Board with a Memorandum of Understanding (MOU) to recognize the new Fiscal/Technology Specialist position within Local 792-CH (Courthouse). She explained that Public Works utilizes specialized programs and systems. The creation of the Fiscal/Technology Specialist recognizes the unique duties that must be performed to maintain these systems. Commissioner Wright moved to approve an MOU between Kittitas County and Local 792-CH to acknowledge the creation of a Fiscal/Technology Specialist. Commissioner Osiadacz seconded the motion. Motion was approved; 2:0.
