Marking your ballot:  
\*\*Use a BLACK or BLUE pen to mark your ballot. To vote for your choice in each contest, completely fill in the box provided to the left of your choice. Unless specifically allowed by law, more than one vote for an office will be an overvote and no votes for that office will be counted.

\*\*To vote for a candidate not appearing on the ballot, completely fill in the box next to the words "Write-in" and write in your choice.

\*\*Replacement Ballot:  
If you have destroyed, damaged or lost your ballot, you may request a Replacement Ballot by contacting the Kittitas County Auditor's Office at 962-7503.

\*\*\*Returning Your Ballot\*\*\*In order for your ballot to be counted, it must be either postmarked or deposited at a designated deposit site no later than the date of the election- August 2. If mailing your ballot, 1st class postage is REQUIRED.

\*\*\*BALLOT DROP BOXES\*\*\*  
A secure drop box is provided inside the lobby of the courthouse.  
>24 hour secure drop boxes are provided at the following locations:  
Upper Kittitas County District Court parking lot (700 E. 1st St, Cle Elum).  
Kittitas County Courthouse parking lot (205 W. 5th Ave, Ellensburg).  
Central Washington University Campus (curbside of the East entrance of the SURC)  
Drop boxes are locked at 8:00pm Election Night.
