10.06.010 Purpose.

The declared purposes of this chapter are to provide parking for the public who are doing business at the Kittitas County Courthouse, to designate certain areas for parking for county employees and county vehicles and to prohibit parking by non-employees in certain designated areas. 10.06.020 Definitions.

~~County Parking Area A~~

~~Includes all of the parking spaces on county property immediately to the south of the Kittitas County Courthouse.~~

~~County Parking Area B~~

~~Includes all of the parking spaces on county property to the west of the Kittitas County Courthouse.~~

~~County Parking Area C~~

~~Includes all of the parking spaces on county property on the Ellensburg city block bordered by 6th Avenue to the north, the north boundary of the adjacent business to the south, the alley to the west and Pearl Street to the east.~~

~~County Parking~~

~~Includes all other properties owned by Kittitas County used for parking.~~

10.06.030 Issuance of parking permits to county employees.

An ~~overnight~~ parking permit shall be issued to each county employee ~~working in the courthouse or the public safety building~~ at the employee's request and at no charge by the ~~accounting~~ [Kittitas County Human Resources](#) department ~~of the office of the Kittitas County auditor~~. 10.06.040 Restrictions in county parking areas.

1. "County Parking Areas ~~A-C~~" ~~is are~~ set aside ~~and usable by exclusively for non-employees~~ [employees and the general public and employees](#) doing business at the Kittitas County Courthouse during normal business hours.

- ~~2. "County Parking Area B" is reserved exclusively for county vehicles and parking by elected officials or designated staff and shall be signed accordingly.~~
- ~~3.2. "County Parking Area C" is reserved for parking by county employees working in courthouse or the public safety building displaying permits on their vehicles and for county vehicles. Reserved spaces for certain vehicles owned by the county shall be identified and signed accordingly; county employees are prohibited from parking in these reserved spaces. (Ord. 89-1 (part), 1989); are designated and signed as "No Overnight Parking-Without Permit" for personal vehicles. County owned vehicles are not required to display overnight Parking Permits. (Ord. 89 1 (part) 1989; Ord. 2015-____)~~

10.06.050 Towing and impounding vehicles violating parking restrictions.

Any vehicle parking in any county parking area in violation of this chapter shall be towed and impounded at the owner's expense. (Ord. 89-1 (part), 1989; Ord 2015-____).

10.06.060 Policy regulating employee and public parking on county properties.

The following shall be the policy regulating employee and public parking on ~~certain~~ county properties:

1. Permits will be issued only to county employees for their use while working at as needed for overnight parking at the Kittitas County Courthouse or Kittitas County Public Safety Building owned parking lots.
2. Permits will be issued yearly by the accounting-Kittitas County Human Resources department of the office of Kittitas County auditor.

- ~~3. will be installed at all County owned p at Parking Lot "C" (6th and Pearl Street):~~

Parking by Permit Only - 8:00 a.m. to 5:00 p.m. Monday - Friday

- ~~5. Spaces will be provided and proper signage installed for 10 county-owned vehicles. This provides space for two vehicles from the road department, five vehicles from the assessor's office, one vehicle from the juvenile department, and two vehicles from cooperative extension. The space reserved for county vehicles shall be signed as follows:~~
