Mr. Ayling:

The Department of Health (DOH) Office of Drinking Water (ODW) has reviewed this application generating the following comments:

- ??? The applicant is stating that they will be provided water from “Game Farm Estates” (AB3256) – Game Farm Estates currently has 27 active and 40 approved connections. Thus, Game Farm Estates does not have capacity to serve this 110 residential home development. So, Game Farm Estates would need to upgrade their capacity – that would need to be reviewed and approved by DOH ODW.
- ??? Does Game Farm Estates agree to serve this development?
- ??? Does this development have a water right to serve 110 residential homes and/or a “mitigation” water right from Kittitas County?
- ??? Is this development within the service area of Game Farm Estates – if not, then Game Farm Estates would need to complete a Water System Plan (to be reviewed and subsequently approved by DOH ODW). Also, a Water System Plan is needed to update water rights information for a water system.
- ??? For assessing and upgrading capacity and for preparing a Water System Plan, DOH ODW requires these efforts to be completed by a Professional Engineer licensed in the State of Washington.
