Thank you for sending out for review. There are a couple of items that WDFW believes should be in the application prior to review or approval:

- 1. The applicant does not show on his site plan the distance to the stream edge to allow for comment on how far proposed setbacks from the creek would be. WDFW would like to see this distance prior to any approval and before the comment deadline in case we may need to make further comment.
- 2. The applicant should be submitting a mitigation plan for potential impacts to the riparian area from encroachment due to the building. That mitigation plan should include strategies to offset any loss of riparian function from vegetation (trees, shrubs) lost from the clearing. Once a mitigation plan is prepared, WDFW would like to review and comment and if necessary meet on site to discuss prior to approval of a mitigation plan. WDFW requests that this mitigation plan be a condition of an approval.



Thank you for the clarification. WDFW does have significant concern with building so close to a Type F (fish habitat). WDFW would not be in support of approving this application without a mitigation plan that ensures there is no net loss of riparian function and habitat. WDFW does not agree with the CAO report that placing a single family residence here (within 50 foot of a Type F creek) will have no negative impact. Further at this site, across the creek, there is also riparian impacts planned (that have been mitigated) through the Ski Acres proposed development. While we appreciate that they have kept the home small, could their site plan include reduction in driveway setback so that they could setback further from the creek.

Regarding the proposal above, the KCFMO does not see a reason why approval should not be granted. The KCFMO also does not see any additional fire, nor emergency risk by granting approval, nor by constructing the proposed single-family residence.

If the review of this application does grant approval, the proposed structure shall be subject to KCFMO Wildland Urban Interface Code evaluations/inspections, which may indicate that automatic fire sprinklers shall be installed, as well as, creating a defensible space which may also require the removal of trees, dead/downed litter, and other natural vegetation.

Thank you for the opportunity to comment on the proposal at parcel # 448135 located off Tanner Way, approximately 0.64 miles from the intersection of Hyak Dr and State Route 906 in Snoqualmie Pass, WA in Section 9, Township 22, Range 11.

Based on a cursory review of aerial imagery, it appears that the parcels are primarily forested land. Due to the possibility of this proposal being within the Riparian Management Zone of a Type F stream, a Forest Practices Application (FPA) may be required (RCW 76.09 and WAC 222). The FPA would need to meet the requirements of the Forest Practices Act and its rules.
