Thanks for sending along. While the number of trees planted increased, the plan did not address several of my earlier comments. Is there a reason why (other than potentially site access with snow)?

Here were my earlier comments. I still don't know what's being removed and there are no riparian plants included. If not removing any trees, that would be helpful to know as well.

"The plan looks incomplete for review. Are they removing any trees? The lot looks fairly treed, so seems difficult to build without removing. If they are removing then the mitigation plan needs to show the number and size of each tree being removed as that's part of the impacts.

The mitigation proposal of 12 conifer trees is insufficient. As discussed on similar proposals, shade and riparian habitat are the main components for these RU near streams, especially fish streams. It will take a long time for conifers to grow up. To compensate for shade and riparian habitat, I would like to see addition of fast growing riparian shrubs along the creek in the planting plan and if they are removing trees (i.e. willow, dogwood etc..), then the mitigation plan should consider either putting those trees in the creek as habitat or if that is not feasible, having discussions of donating those trees to any nearby habitat projects. To have those discussions, the plan needs to show what trees (where and size) are being impacted. "
