Jeremiah,

While I appreciate they added a few elements, it is really difficult to comment if this plan is adequate because they didn't include one of the items I was requesting:

1. What are the size of the trees being removed and where are they located, they mention 12 in the email but don't talk about their size or position to the creek (how much are they contributing to shade of the creek)?

We need to determine shade inputs to the creek. If the current trees to be removed are large and we are only proposing to replant small conifers which only grow about maybe a foot a year, there will be significant impacts in the shade of the stream during the next few decades. It looks like they are only proposing a very small patch of fast growing willow, which likely won't offset shade impacts if they are clearing trees in all of the areas they are replanting. So, we need some solutions for the loss of shade. Are they ok with leaving some of the trees nearest to the stream that are contributing the most to the shade? Is placing some of the trees in the creek as a means for shade (like we did at adjacent Ski Acres-maybe work with the owners there if they control the creek area)?
