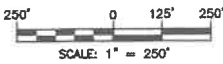
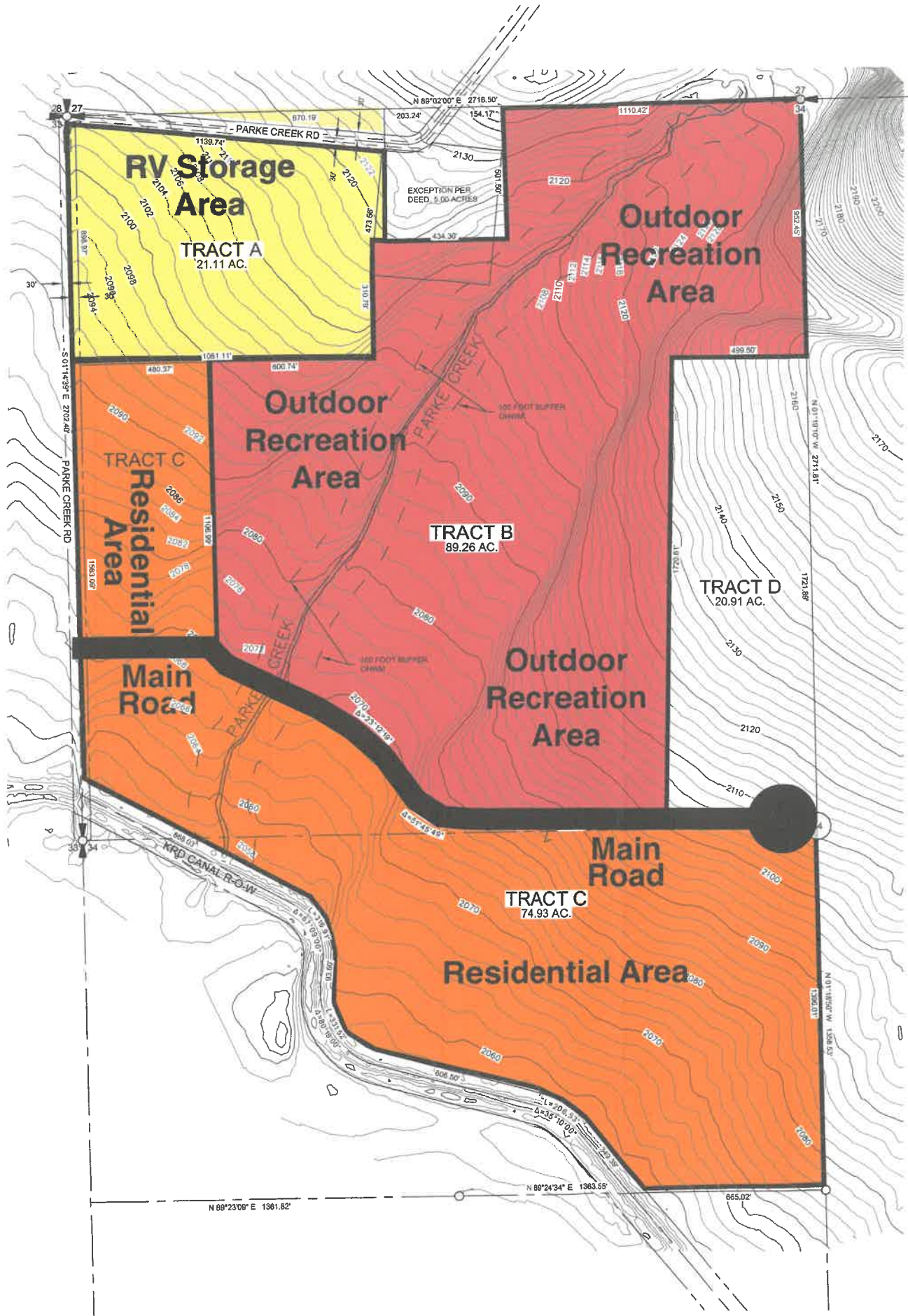


SITE DEVELOPMENT PLAN - PARKE CREEK LANDING

THE NORTHWEST QUARTER AND THAT PORTION OF THE NORTH HALF OF THE SOUTHWEST QUARTER LYING ABOVE THE RIGHT OF WAY OF THE CANAL OF THE KITITAS RECLAMATION DISTRICT, IN SECTION 34, IN TOWNSHIP 18 NORTH, RANGE 20 EAST, W.M., IN THE COUNTY OF KITITAS, STATE OF WASHINGTON.

THAT PORTION OF THE NORTH HALF OF THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 18 NORTH, RANGE 20 EAST, W.M., KITITAS COUNTY, WASHINGTON WHICH IS BOUNDED BY A LINE DESCRIBED AS FOLLOWS: BEGINNING AT THE NORTHWEST CORNER OF SAID SECTION 34; THENCE N 90°00'00" E, ALONG THE NORTH BOUNDARY OF SAID SECTION 34, 1173.78 FEET TO THE TRUE POINT OF BEGINNING; THENCE N 90°00'00" E, 434.30 FEET; THENCE S 501.50 FEET; THENCE S 60°00'00" W, 434.30 FEET; THENCE NORTH 501.50 FEET TO THE TRUE POINT OF BEGINNING.

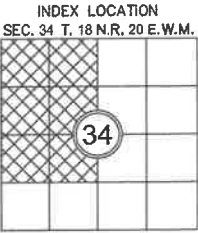
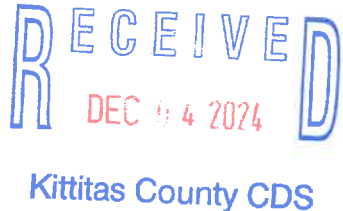
