Thank you for the opportunity to comment on the Notice of Application for the Brown Short Plat. We have reviewed the application and have the following comments.

Water Resources Program

In Washington State, prospective water users must obtain authorization from the Department of Ecology before diverting surface water or withdrawing ground water, with one exception. Ground water withdrawals for a project up to 5,000 gallons per day used for single or group domestic supply, up to 5,000 gallons per day used for industrial purposes, stock watering, and for the irrigation of up to one-half acre of non-commercial lawn and garden are exempt from the permitting process. Water use under the RCW 90.44.050 exemption establishes a water right that is subject to the same privileges, restrictions, laws and regulations as a water right permit or certificate obtained directly from Ecology. Hi Bradley,

WDFW doesn't have many comments about this proposal, but the watercourse along the northern portion of this parcel appears to be an irrigation return. This feature is worth mentioning because of how entrenched it is and that it poses potential erosion concerns in the future. This feature also flows directly to the Yakima River, so ensuring good water quality in this watercourse helps ensure good water quality in the Yakima River and protection of aquatic life in the river. For this reason, we recommend future building setbacks treat this water feature with adequate riparian setbacks of at least 100 feet.
