Thank you for the opportunity to review and comment on AU-24-00006, which proposes the addition of an accessory dwelling unit (ADU) on Kittitas County parcel 956834. The Washington Department of Fish and Wildlife had a site visit on this parcel in 2022 to map the location of Tillman Creek, a perennial fish-bearing tributary to the Yakima River. Tillman Creek is present near the southeastern corner of the parcel and is correctly labeled on the applicant's site plans and we appreciate the setback buffer labeled as well. We have no further comments on the proposal.

To note for future planning in this vicinity, DNR's stream layer (as shown on Compas) incorrectly maps Tillman Creek to the west of it's true location. However, the location of the stream channel can be more accurately identified by looking at the LiDAR.
