Proposal: The applicants have proposed the addition of an accessory dwelling unit (ADU) to the existing property, with a total habitable space of 1207 square feet, attached to the existing garage. Appeals to an administrative land use decision may be filed within 10 working days with Kittitas County Community Development Services as outlined in Chapter 15A.07 of the Kittitas County Code. The current appeal fee is \$1670.
