

## PART OF THE TOWNSHIP 19 NORTH, SOUTHEAST RANGE 18 QUARTER OF EAST, W.M SECTION , 83

- 3. ACCORDING TO KITITAS RECLAMATION DISTRICT (KRD) RECORDS, PARCEL 1A HAS 3 IRRIGABLE ACRES; PARCEL 1B HAS 5 IRRIGABLE ACRES, KRD WATER MAY ONLY BE APPLIED TO IRRIGABLE ACREAGE.
