Good Morning, Zach

I wanted to thank you for the time taken to review comments on this project. However, since this project is to create a housing subdivision clearly there is going to be extensive ground disturbing activity here. As stated in the previous letter (attached) there is Very High probability of encountering archaeological remains in this area based on DAHP's predictive model. Further, Nelson Siding Road appears to have overlain the original wagon/military/corduroy road that ran from Ellensburg through Snoqualmie Pass and on to Seattle; and there are two settler-era cabins listed in the Project Area, as displayed by the 1892 GLO map by Amos Shaw. Nelson's Siding was itself a siding for the Northern Pacific Railroad, and was a Section Camp during construction of the line (though the siding itself was roughly 2.5 miles to the east, locals referred to the road by that name).

Finally, because a survey was requested by DAHP and the Tribes, if archaeology is impacted by the Project, it may not be considered an inadvertent discovery, but rather a violation of RCW 27.53. These requests are not made arbitrarily, they are decisions that are made based on professional knowledge and experience of DAHP and Tribal professionals, and reliance on scientific data intended both to protect our shared cultural heritage and ultimately to save proponents time and money for their projects.
