I. GENERAL INFORMATION

<u>Requested Action</u>: Ivana Halvorsen, Barghausen Consulting Engineers of Kent WA, authorized agent for Starlite Construction, LLC, landowners, applied for a 32-lot Performance Based Cluster Plat on approximately 50 acres of land that is zoned Rural-3. The project is proposed to be served by a public water system with individual septic systems or a community drain field.

Location: The project is located south of the town of South Cle Elum located off Westside Road, South Cle Elum, WA 98943, in a portion of Section 1, T19N R14E WM in Kittitas County. Map number 19-14-01054-0002.

<u>Access</u>: The proposed project will have access from a new road to be constructed off Westside Road. The new road will require the construction of a bridge to cross the KRD canal. The road will be within a 60-foot right-of-way tract. The project also has access from Stone Ridge Drive, a 60-foot private access easement. The project also has access to Pasco Road, a County road.

Zoning and Development Standards: The subject property is located within the Rural-3 zoning district. The purpose and intent of the Rural-3 zone is to provide areas where residential development may occur on a low density basis. A primary goal and intent in siting R-3 zones will be to minimize adverse effects on adjacent natural resource lands. Applicable development standards set forth in KCC Chapter 17.30 include, but are not limited to the following:

Lot Size: The minimum residential lot size shall be three acres in the Rural-3 zone. The overall density of any residential development shall not exceed one dwelling for each three acres, except

as provided for in Kittitas County Code 16.09, Performance Based Cluster Platting.

Setbacks: There shall be a minimum front yard setback of twenty-five feet. Side yard and rear yard setbacks shall be 15 feet.

<u>Preliminary Plats:</u> The requirements of KCC Chapter 16.08.200, "Subdivision" means the division or re-division of land into five or more lots, tracts, parcels, sites or divisions for the purpose of sale, lease or transfer of ownership any one of which is less than 20 acres.

III. ADMINISTRATIVE REVIEW

<u>Notice of Application</u>: A complete long plat application was submitted to Community Development Services on April 10, 2007. The Notice of Application for the preliminary plat application was issued on October 31, 2007. This notice was published in the official county paper of record and was mailed to jurisdictional government agencies, adjacent property owners and other interested parties. The last day to submit written comments was on November 15, 2007.

IV. COMPREHENSIVE PLAN

The Kittitas County Comprehensive Plan designates the subject property as Rural. Kittitas County has established the following goals and policies to guide future housing developments. These goals and policies were developed in response to existing housing conditions and identified needs within the county, and support the County Wide Planning Policies:

GPO 3.1 Provide a sufficient number of housing units for future populations in rural areas of Kittitas County.

GPO 3.6 Provide for future populations while protecting individual property rights.

GPO 3.17 Provide a sufficient number of housing units for future populations while maintaining the rural character of Kittitas County.

GPO 3.18 Provide sufficient housing units while maintaining environmental quality.

GPO 8.5 Kittitas County recognizes and agrees with the need for continued diversity in densities and uses on Rural Lands.

GPO 8.46 Residential development in rural lands must be in areas that can support adequate private water and sewer systems.

V. ENVIRONMENTAL REVIEW

Based upon review of the submitted application materials including an environmental checklist, correspondence received during this 15 day comment period and other information on file with Community Development Services, a Mitigated Determination of Non-Significance (MDNS) was issued on October 30, 2009. The appeal period ended on November 13, 2009 at 5:00 p.m. No appeals were filed.

VI. AGENCY AND PUBLIC COMMENTS

Applicable agencies, adjacent property owners, and interested parties have been given the opportunity to review this proposal. All comments have been included as Exhibits in the Hearing Examiner packet.

VII. PROJECT ANALYSIS

In review of this proposal it is important to consider the goals and policies of the comprehensive plan, applicable county code, public and agency comments, any identified environmental concerns and state and federal requirements. Identified below is planning staff's analysis and consistency review for the subject application.

Comprehensive Plan Consistency:

The proposal is consistent with the goals and policies of the Kittitas County Comprehensive Plan. The proposed subdivision will be adequately served by rural levels of service. The lots will be served by a public water system and private septic systems or community drainfields. Staff has conducted an administrative critical area review in accordance with KCC 17A and found significant critical areas which include wetlands and steep slopes.

Consistency with the provisions of KCC 16.09: Performance Based Cluster Platting:

This proposal is not consistent with the Kittitas County Subdivision Code for PBCP. In accordance with KCC 16.09.030 and KCC 16.09.100C, the minimum required open space acreage for Starlite Heights is 40% of the project site, or 20.13 acres.

Consistency with the provisions of KCC 16.12: Preliminary Plat Subdivision Code:

This proposal is not consistent with the Kittitas County Subdivision Code for Preliminary Plats. The page size is too large. KCC 16.12 requires page sizes to be 18 x 24 inches, and the submitted pages are 24 x 36 inches. Widths of roadway tracts are not shown. The plat does not conform to zoning regulations and lot size as required in KCC 16.12.040 and 16.12.090.

Consistency with the provisions of KCC Title 12: Roads and Bridges:

All roads are required to meet all Kittitas County Road Standards as outlined in the October 28, 2009 memorandum issued by the Department of Public Works. As conditioned, the proposal is consistent with the provisions of KCC Title 12.

Agency Comments:

The following agencies provided comments during the comment period: Department of Ecology, Department of Archaeology & Historic Preservation, Fire District 7, Kittitas County Fire Marshal, Kittitas County Department of Public Works and Environmental Health, Washington Department of Fish and Wildlife, Bonneville Power Administration. These comments have been included as conditions of approval to address these agency concerns.

Public Comments:

Numerous letters from the public were submitted on this proposal at the time of staff review. These comments have been included as conditions of approval to address the concerns.

VIII. RECOMMENDATION

As conditioned below, the application does not appear to be detrimental to the general public health, safety or welfare and meets the basic intent and criteria associated with Title 12 and Title 16.12 of the Kittitas County Code and the Kittitas County Comprehensive Plan. Staff recommends approval of the Starlite Heights Preliminary Plat LP-07-16, subject to the following findings of fact and conditions:

Suggested Findings of Fact

1. Ivana Halvorsen, Barghausen Consulting Engineers of Kent WA, authorized agent for Starlite Construction, LLC, landowners, applied for a 32-lot Performance Based Cluster Plat on approximately 50 acres of land that is zoned Rural-3. The project is proposed to be served by a public water system with individual septic systems or a community drain field.

3. Site Characteristics:

- 4. Site Characteristics: Wetland is located on the property. The remainder of the property is hilly.
- 5. The Comprehensive Plan designation is Rural.
- 6. The subject property is zoned Rural-3. The minimum residential lot size shall be three acres in the Rural-3 zone. The overall density of any residential development shall not exceed one dwelling for each three acres, except as provided for in Kittitas County Code 16.09, Performance Based Cluster Platting.
- 7. A complete long plat application was submitted to Community Development Services on April 10, 2008. The Notice of Application for the preliminary plat application was issued on October 31, 2007. This notice was published in the official county paper of record and was mailed to jurisdictional government agencies, adjacent property owners and other interested parties. The last day to submit written comments was on November 15, 2007.
- 8. Based upon review of the submitted application materials including an environmental checklist, correspondence received during this 15 day comment period and other information on file with Community Development Services, a Mitigated Determination of Non-Significance (MDNS) was issued on October 30, 2009. The appeal period ended on November 13, 2009 at 5:00 p.m. No appeals were filed.
- 9. The proposal is consistent with the goals and policies of the Kittitas County Comprehensive Plan. The proposed subdivision will be adequately served by rural levels of service. The lots will be served by a public water system and private septic systems or community drainfields. Staff has conducted an administrative critical area review in accordance with KCC 17A and found significant critical areas which include wetlands and steep slopes.
- 10. This proposal is not consistent with the Kittitas County Subdivision Code Chapter 16.12 for Preliminary Plats or KCC 16.09 Performance Based Cluster Plats.
- 11. All roads are required to meet all Kittitas County Road Standards as outlined in the October 28, 2009

memorandum issued by the Department of Public Works. As conditioned, the proposal is consistent with the provisions of KCC Title 12.

12. The following agencies provided comments during the comment period: Department of Ecology, Department of Archaeology & Historic Preservation, Fire District 7, Kittitas County Fire Marshal, Kittitas County Department of Public Works and Environmental Health, Washington Department of Fish and Wildlife, Bonneville Power Administration. These comments have been included as conditions of approval to address these agency concerns.

Suggested Conclusions:

- 1. As conditioned, the development meets the goals, policies and implementation recommendations as set forth in the Kittitas County Comprehensive Plan.
- 2. As conditioned, this proposal is consistent with applicable federal and state laws and regulations.
- 3. Public use and interest will be served by approval of this proposal.
- 4. As conditioned, the proposal is consistent with Kittitas County Code Title 16 Subdivision, Title 17 Zoning, Title 17A Critical Areas, Title 15 Environmental, and Title 12 Roads and Bridges.

Suggested Conditions of Approval:

- 1. The project shall proceed in substantial conformance with the plans and application materials on file dated April 10, 2007 and revised August 14, 2009 except as amended by the conditions herein.
- 2. Open space calculations shall be adjusted to comply with KCC 16.09. Open space requirements shall be calculated from the total parcel size and not the total developable project area. In accordance with KCC 16.09.030 and KCC 16.09.100C, the minimum required open space acreage for Starlite Heights is 40% of the project site, or 20.13 acres. The plat shall be revised to clearly demonstrate meeting this requirement. The face of the final plat shall contain the following note: "The open space shall remain in perpetuity and can not be further subdivided."
- 3. The Performance Based Cluster Platting conveyance instruments and the face of the final plat shall contain the following notice: The subject property is within or near existing agricultural or other natural resource areas on which a variety of activities may occur that are not compatible with residential development for certain periods of varying duration. Agricultural or other natural resource activities performed in accordance with county, state and federal laws are not subject to legal action as public nuisances. Kittitas County has adopted right to farm provisions contained in Section 17.74 of the Kittitas County Zoning Code.
- 4. Open space acreage shall be shown on the final plat.
- 5. A certificate of title of the property proposed to be platted shall be submitted with the final plat.
- 6. A note shall be placed on the final plat stating that any construction within areas of 33% or greater slope will require geotechnical engineering per IRC R403.7.7 and/or IRC 1805.3.1 or current adopted code.
- 7. The applicant is responsible for compliance with all applicable local, state and federal rules and regulations, and must obtain all appropriate permits and approvals.
- 8. All current and future landowners must comply with the International Fire Code.

- 9. It is the responsibility of the applicant to contact the Kittitas County Assessor's and Treasurer's offices to confirm all taxes are current prior to final plat approval.
- 10. Computer sheets shall be submitted with the final plat showing the closure of plat boundaries, blocks, lots or any tract. It is the responsibility of the Professional Licensed Surveyor (PLS) to ensure the lot closures are correct and accurate.
- 11. Soil logs need to be scheduled and dug at a mutually convenient time. The developer/owner shall provide soil logs as per Chapter 246-272 WAC or as amended. The information obtained will be recorded and placed in the plat file for future reference. The information obtained from these soil logs is for plat approval purposes only and does not constitute a site evaluation in conjunction with the issuance of a permit for any specific lot.
- 12. According to the Public Health Department, individual final plat approval will be conditioned upon: a. Completion of soil logs which meet the septic availability requirement;
 - b. Documentation from the State of Washington Department of Ecology verifying that the quantity of water required for the plat has been transferred;
 - c. Placement of all proposed wells and submittal of well logs showing yields consistent with the requirement above and the require nitrate and bacteriological tests showing potability of that water.
- 13. All applicants for subdivision utilizing wells shall have a note placed on the face of the final mylars that states: "
 - a. "The approval of this division of land included no guarantee that there is a legal right to withdraw groundwater within the land division. The approval of this division of land provides no guarantee that use of water under the ground water exemption (RCW 90.44.050) for this plat or any portion thereof will not be subject to curtailment by the Department of Ecology or a court of law."
 - b. "Metering will be required on all new residential well connections and metering results shall be recorded in a manner consistent with Kittitas County and Washington State Department of Ecology requirements."
- 14. The Final Plat shall meet all requirements as listed in Chapter 16.20 of the Subdivision Code, as follows:

16.20.020 Final Plat General Information

- a. The final plat shall be drawn on polyester film in a neat and legible manner.
- b. The final plat shall be drawn to such a scale as to make a sheet eighteen inches by twenty-four inches. Should this size sheet unduly congest the drawing, the plat may be submitted on two or more sheets of the above dimensions. The perimeter of the subdivision shall be depicted with heavier lines than appear elsewhere on the plat. A marginal line shall be drawn completely around each sheet, leaving an entirely blank margin of one inch on the sides. The scale shall be one (1) inch equals two hundred (200) feet, or greater, unless otherwise approved by the director.
- c. All lettering shall be printed with permanent ink.
- d. Each sheet of the final plat shall contain the subdivisions name at the top of the sheet in large letters followed underneath with the section, township, range, county and state. The space for recording the receiving number is in the upper right hand corner, sheet numbers at the bottom of the sheets.
- e. It shall show all courses and distances necessary to re-stake any portion of said plat.
- f. Required monuments shall be shown together with a legend of monuments on the face of each plat sheet. (Ord. 2005-31, 2005)

16.20.040 Plat Drawing

- a. Section Data. All section, township, municipal and county lines lying within or adjacent to the subdivision;
- b. Tie Monuments. The location of all monuments or other evidence used as ties to establish the subdivision's boundaries;
- c. Plat Monuments. The location of all permanent control monuments found or established within the subdivision;
- d. Boundaries. The boundary of the subdivision, with complete bearings and lineal dimensions in heavier lines;
- e. Bearing and Distances. The length and bearings of all straight lines, the radii, arcs, and central angles of all curves;
- f. Lot Dimensions. The length of each lot line, together with bearings and other data necessary for the location of any lot line in the field;
- g. Road Names. The location, width, centerline, and name or names or number of all streets within and adjoining the subdivision;
- h. Easements. The location and width, shown with broken lines, and description of all easements. Easements may be described in the plat restrictions in lieu of being shown on the plat drawings;
- i. Lot Numbers. Numbers assigned to all lots and blocks within the subdivision;
- j. Adjacent Owners. Names of owners of land adjacent to the subdivision, and the names of any adjacent subdivisions;
- k. Surrounding Area. All surrounding property shall be shown in dotted lines and letters with names of plats, roads, adjoining lots, canals, and etc., and if un-platted shall be so indicated;
- 1. Vicinity Maps. A vicinity map showing the boundary of the plat in relation to the surrounding area such as adjacent subdivisions, rivers, creeks, roads or highways, canals, etc. Minimum area shown would be the section or sections containing the platted area with a scale of approximately 4" = 1 mile;
- m. Contours. Contour lines are not shown on a final plat as required on the preliminary plat;
- n. Miscellaneous Items. North arrow, scale and legend of monuments to be shown on open area of sheets;
- o. Grid Coordinates. A tie shall be made and shown on the plat if plat is within one mile of any such monument.
- p. Well location. The drawings shall be marked with a "w" indicating location of the well and a broken line showing the one hundred foot radius around such.
- q. Ditches. Location of existing ditches apparent or of record. (Ord. 2005-31, 2005)
- 15. This application is subject to the latest revision of the Kittitas County Road Standards, dated 9/6/05. The following conditions apply and must be completed prior to the issuance of a building permit for any of the residence within this plat. A Performance Bond or acceptable financial guarantee may be used, in lieu of the required improvements, per the conditions outlined in the current Kittitas County Road Standards.
- 16. Private roads serving any of the lots within this development shall be inspected and certified by a licensed professional engineer for conformance with current Kittitas County Road Standards, 9/6/05 edition. Kittitas County Public Works shall require this road certification to be completed prior to the issuance of a building permit for any of the structures within the proposed plat.
- 17. The main access road leading from Westside Road to Danko Road shall be constructed as a High-Density Private Road that serves more than 40 lots. Access easements shall be a minimum of 60' wide. The roadway shall be constructed to AASHTO standards, have a maximum grade of 12%, and be designed by an engineer. Design plans shall be approved by the County Engineer prior to construction. See current Kittias County Road Standards, 9/6/05 edition.

Access roads that stem off the main road shall be constructed to meet or exceed the conditions of a High-Density Private Road that serves 15-40 tax parcels. See current Kittitas County Road Standards, 9/6/05 edition.

- a. Access easements shall be a minimum of 60' wide. The roadway shall have a minimum width of 22', with 1' shoulders, for a total width of 24'.
- b. Minimum centerline radius shall be 60'.
- c. Surface requirement BST/ACP.
- d. Maximum grade is12%.
- e. Stopping site distance, reference AASHTO.
- f. Entering site distance, reference AASHTO.
- g. Maintenance of driveway approaches shall be the responsibility of the owner whose property they serve. The County will not maintain accesses.
- h. Any further subdivision or lots to be served by proposed access may result in further access requirements.
- i. All roads located within this development or roads that provide access to this development shall be constructed to current county road standards unless any other maintenance agreements, forest service road easements or state easements require higher road standards. The higher of the road standards shall apply.
- j. All easements shall provide for AASHTO radius at the intersection with a county road.
- k. A paved apron shall be constructed at the intersection of the proposed private intersection and the county road right-of-way.
- 18. A cul-de-sac turn-around having an outside right-of-way or easement diameter of at least 110 feet shall be constructed at the closed end of all dead-end roads serving 3 or more lots. The driving surface shall be at least 96 feet in diameter. Cul-de-sacs must also conform to the requirements specified by the 2006 International Fire Code. Contact the Fire Marshal regarding any additional cul-de-sac requirements.
- 19. The bridge over the canal shall be constructed to the requirements of KCRS 12.07. The bridge shall have a load rating of at least 75,000 lbs and have a width that will accommodate the lanes and shoulders. The bridge design shall be approved by the County Engineer prior to construction. A licensed engineer familiar with bridges shall certify that the bridge meets these requirements as specified in KCRS 12.07.030 and the bridge certification shall be provided with the road certification.
- 20. Plat notes shall reflect the following:
 - a. Entire private road shall achieve 95% compaction and shall be inspected and certified by a licensed engineer in the State of Washington specifying that the road meets current Kittitas County Road Standards prior to the issuance of building permit for this plat.
 - b. Entire private road shall be inspected and certified by a civil engineer licensed in the State of Washington specifying that the road meets Kittitas County Road Standards as adopted September 6, 2005, prior to the issuance of a building permit. Any future subdivision or land use action will be reviewed under the most current road standards.
 - c. Kittitas County will not accept private roads for maintenance as public streets or roads until such streets or roads are brought into conformance with current County Road Standards. This requirement will include the hard surface paving of any street or road surfaced originally with gravel.
 - d. Maintenance of the access is the responsibility of the property owners who benefit from its use.
 - e. An approved access permit will be required from the Department of Public Works prior to creating any new driveway access or performing work within the county road right-of-way.
 - f. Any further subdivision or lots to be served by proposed access may result in further access requirements. See Kittitas County Road Standards.
 - g. A public utility easement 10 feet in width is reserved along all lot lines. The 10 foot easement shall

abut the exterior plat boundary and shall be divided 5 feet on each side of interior lot lines. Said easement shall also be used for irrigation.

21. All plats must show the acceptance signature of the County Engineer. The acceptance block shall be as follows (per KCC 16.24.170):

EXAMINED AND APPROVED This _____day of _____, A.D., 20____.

- 22. The applicant shall meet all applicable conditions of any pre-established or required Private Road Maintenance Agreements.
- 23. It is the responsibility of the Professional Licensed Surveyor (PLS) to ensure the lot closures are correct and accurate.
- 24. An approved access permit shall be required from the Department of Public Works prior to creating any new driveway access or performing work within the county road right of way.
- 25. Contact the Kittitas County Rural Addressing Coordinator at (509) 962-7523 to obtain addresses prior to obtaining a building permit. A parcel cannot receive a building permit or utilities until such parcel is identified with a 911 address.
- 26. Contact the Kittitas County Fire Marshal regarding any additional access requirements for Emergency Response.
- 27. The U.S. Postal Service requires that private roads with 6 or more residences install USPS approved Cluster Box Units (CBUs) at a safe location at the mouth of the private road. Contact your local Post Office for location and additional design requirements before beginning construction.
- 28. A burn permit must be obtained from Ecology if the proponent plans to burn trees or debris from the property. Only natural, unprocessed vegetation may be burned in an outdoor fire.
- 29. Washington Administrative Code (WAC) 173-400-040 requires that reasonable precaution be taken to prevent dust from leaving the site. Also, dust is prohibited from interfering unreasonable with the use and enjoyment of property, causing health impacts, or damaging property or business.
- 30. The proponent should create a site-specific Fugitive Dust Control Plan (FDCP) before starting this project, according to Department of Ecology standards, and then follow the plan for the construction of the project and the duration of activity on the property.
- 31. A plat note discussing the spread of noxious weeds shall be shown on the plat and shall read: "Per RCW 17.10.140 Landowners are responsible for controlling and preventing the spread of noxious weeds, accordingly, the Kittitas County Noxious Weed Board recommends immediate reseeding of areas disturbed by development to preclude the proliferation of noxious weeds."
- 32. All applicable survey data and dedications shall be reflected pursuant to KCC 16.24: Survey Data-Dedications.
- 33. Both sheets shall reflect the Plat number: LP-07-18.

- 34. An NPDES Construction Stormwater General Permit from the Washington State Department of Ecology is required if there is a potential for stormwater discharge from a construction site with more than one acre of disturbed ground. This permit requires that the SEPA checklist fully disclose anticipated activities including building, road construction and utility placements. Obtaining a permit is a minimum of a 38 day process and may take up to 60 days if the original SEPA does not disclose all proposed activities.
- 35. This NPDES Construction Stormwater General Permit requires that a Stormwater Pollution Prevention Plan (Erosion Sediment Control Plan) is prepared and implemented for all permitted construction sites. These control measures <u>must</u> be able to prevent soil from being carried into surface water (this includes storm drains) by stormwater runoff. Permit coverage and erosion control measures must be in place prior to any clearing, grading, or construction.
- 36. The Washington Department of Archeology and Historic Preservation (DAHP), has stated that the area has the potential for archaeological resources: there are known sites nearby and the SEPA application indicates there is a historic homestead on the property (Pasco Homestead). The applicant shall immediately contact the Washington State Department of Archaeology & Historic Preservation, and the Yakama Nation if any items of possible cultural or historic significance are encountered during construction activities. Work shall be immediately halted within the area and a large enough perimeter established in order to maintain the integrity of the site (*see* RCW 27.44 and RCW 27.53).
- 37. Design and construction must comply with Kittitas County Code, Kittitas County Zoning, the 2006 International Fire & Building Codes, and all other development agreements.
- 38. Given the provided pre-review documents, these residences will require fire flow of 1000 gallons per minute; however, a reduction in fire flow requirements of 50 percent is allowed when the buildings are provided with an approved automatic sprinkler system.
- 39. An approved water supply capable of supplying the required fire flow for fire protection shall be provided. A standpipe or hydrant system with an adequate source of water, a distribution system and adequate pressure for delivery shall be installed for this plat. Hydrant spacing shall comply with International Fire Code and its appendices' requirements.
- 40. A separate permit and deposit shall be required for installation of a hydrant/standpipe system.
- 41. If this is a gated community, approval for the gate and key box system is required.
- 42. No slope or grade greater than 12% shall be allowed.
- 43. Secondary access, as shown on the plat maps, shall meet minimum Kittitas County Road Standards, as well as the International Fire Code requirements.
- 44. Based on comments received during the public comment period and other information submitted with this project permit application, A SEPA Mitigation Determination of Non-Significance (MDNS) was issued by Community Development Services on October 30, 2009. The following are the mitigation contained within the MDNS and shall be conditions of approval:

Cultural Resources and Historic Preservation

a. The Pasco Homestead properties have been identified by the Washington Department of Archaeology and Historic Preservation (DAHP) as a site with potential cultural resource significance. There is a potential for additional cultural resources on the site, as well. A professional archaeological survey of the project area shall be conducted prior to ground disturbing activities. Prior to moving any structures associated with the Pasco Homestead, this property shall be evaluated, and should include completion of a Historic Property Inventory.

Stormwater

b. On-site stormwater management that conforms to the specifications of the most current version of the Stormwater Management Manual for Eastern Washington is required of this development. Stormwater systems shall be designed to store stormwater generated by a 24-hour, 25-year storm event. Stormwater system designs shall be prepared and stamped by a civil engineer licensed in the State of Washington. The stormwater system design shall be presented to Public Works and approved by the County Engineer prior to final approval. The stormwater system construction shall be certified by a licensed engineer. The certification shall be included with the road certification and is required prior to the issuance of a building permit.

Transportation

- c. <u>Right Turn Pocket</u>: Traffic volumes generated by these residential developments warrant the addition of a right turn pocket or right turn taper from Westside Road eastbound into the new site access. The applicant shall design and construct this improvement. Approval of the construction plans by the County Engineer is required prior to beginning construction. The configuration requirements are shown in WSDOT Design Manual Figure 910-12. The applicant shall meet all requirements of Kittitas County Road Standards for the construction of a public road. The turn lane shall be constructed and approved by Public Works prior to receiving any building permits. Additional right-of-way may be required.
- d. <u>Second Access</u>: There are up to three potential accesses points for this project, Pasco Road, Stone Ridge Drive, and a yet to be constructed private road. Prior to final approval the property owner shall notify Public Works and identify which road serves as the primary access for the requested final plat. If the primary access is a road that serves more than 40 lots, a second access will be required-with the following requirements: 1) If the second access is restricted to emergency access only, it must meet or exceed the following requirements: 60' easement, 20' roadway width, BST/ACP surface, and a paved apron. Access restrictions such as gates or bollards must be approved by the Fire Marshal; 2) If the second access is to be used for ingress and egress, it must meet the same standards of the first access.

The primary and second access shall be bonded for or constructed and certified by a licensed engineer prior to receiving building permits.

- e. <u>Right-of-Way</u>: The right of way for the proposed plats shall be designed for the construction of a road with at least a 25 mph design speed. The right of way will be privately owned, but may be dedicated in the future to Kittitas County for the construction of a new county road. This dedication will occur when requested by the County, or when the road is brought to County public road standards and accepted onto the County road system by the Board of County Commissioners.
- f. <u>BPA Land Use Agreement</u>: A signed and completed BPA Land Use Agreement is required prior to final approval. Based on BPA's policies, adjustments to the road locations may be required. If the road locations are moved, Public Works shall re-review the new road locations for conformance with Kittitas County Road Standards, and to ensure a 25 mph design speed.

Wetlands and Wildlife

g. Prior to final plat approval, the Applicant shall provide a plan demonstrating wetland enhancement, as described in the ESA Adolfson *Meadow Springs, Starlite Estates, and Tamarack Ridge Wetland*

Report, dated September 2007. Specifically, the wetland enhancement plan shall demonstrate: enhancement of existing low value wetland areas and additional areas of wetland enhancement (it is anticipated that portions of Wetland B will be targeted for wetland enhancement). The enhanced wetland would provide additional water quality improvement functions, wildlife habitat value, and increased plant species diversity.

<u>Noise</u>

- h. Development and construction practices for this project shall only occur between the hours of 7:00am to 7:00pm to minimize the effect of construction noise on nearby residential properties.
- 45. The following mitigation conditions from the SEPA Mitigated Determination of Non-Significance shall be noted on the face of the final plat and included in the Covenants, Conditions, and Restrictions (CC&Rs) document recorded with the final plat:
 - a. If fencing is proposed for any lot of the Meadow Springs Performance Based Cluster Plat, it shall be a two-rail split fence design no greater than 42 inches in height in order to encourage wildlife presence and to facilitate wildlife passage.
 - b. All outdoor lighting shall be shielded and directed downward to minimize the effect to nearby residential properties.
