Robin and Jayne Schmaus, landowners, submitted a complete application on October 18, 2007 and the project was deemed complete on April 4, 2008 upon receipt of the SEPA Checklist. The proposal is for a preliminary plat to subdivide approximately 22.95 acres into 7-lots that is zoned Ag-3. The proposed lot sizes are between 3.00 acres and 3.58 acres.

The subject property is located south of Interstate-90, north of Nelson Siding Road, east of Talmadge Road, Cle Elum, WA 98922, and is located in a portion of Section 21, T20N, R14E, WM, in Kittitas County. Map number 20-14-21033-0003.

Kittitas County Community Development Services issued a Notice of Application pursuant to KCC 15A.03 on April 17, 2008. Said notice solicited comments from interested jurisdictional agencies and landowners within 500 feet. The legal Notice of Application was published in the Daily Record on April 17, 2008.

On July 22, 2008, The Kittitas County Planning Commission motioned to forward the Schmaus #4 Preliminary Plat to the Board of County Commissioners with a recommendation of approval. The motion passed by a vote of 4/0. Findings of Fact were approved on October 14, 2008.

and directed staff to prepare enabling documents.


