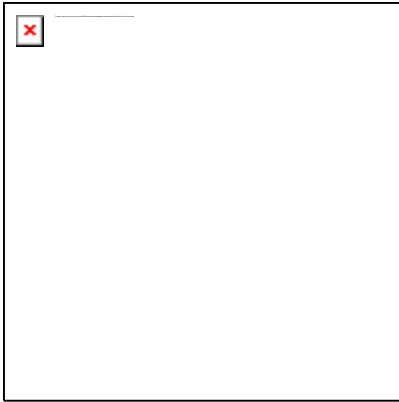
I put this project on pause, Bradley, but I would like to go ahead and finish it up. Thank you again for your help with all of this.

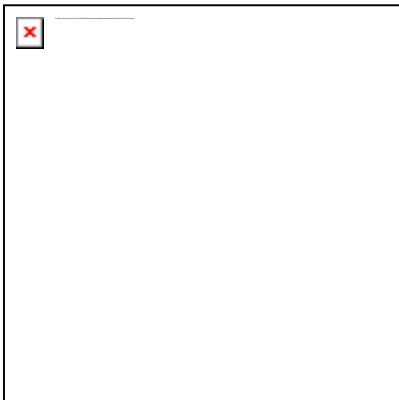
