PARCEL B:

That portion of the West half of the West half of the Northwest Quarter of the Southwest Quarter of the Northeast Quarter of Section 16, Township 17 North, Range 17 East, W.M., records of Kittitas County, State of Washington, lying South of the Manastash Creek.

TOGETHER WITH all water rights and irrigation ditches appurtenant thereto, if any.

TOGERHER WITH and SUBJECT TO an easement over and across a 15 foot readway commencing at the Manastash Road, running southerly to the North boundary line of that portion of the East 1/4 of the West 1/2 of the Northwest 1/4 of the Southwest 1/4 of the Northeast 1/4 lying South of Manastash Creek as recorded under Fittites County Audito's File No. 132724, recorded September 14, 1986, records of said County.

TOGETHER WITH and SUBJECT TO an easement 30 feet in width for ingress and agrees commencing at the Manastash Road, running southerly to the Worth boundary line of that portion of the East 1/4 of the West 1/2 of the Northwest 1/4 of the Southwest 1/4 of the Northeast 1/4 lying South of Manastash Creek; the centerline of which is the center of that roadway and 15 foot easement recorded under Kittitas County Auditor's File No. 332724, recorded September 14, 1966, records of maid County.
