



- THIS SURVEY WAS PERFORMED USING A TRIMBLE S SERIES, 3" TOTAL STATION WITH RESULTING ACCURACY THAT MEETS OR EXCEEDS STANDARDS PER WAC 332-130-090.
- THE INFORMATION ON THIS MAP REPRESENTS THE RESULTS OF A SURVEY MADE IN JUNE OF 2021 AND SEPTEMBER OF 2023 AND CAN ONLY BE CONSIDERED AS INDICATING THE GENERAL CONDITIONS EXISTING AT THAT TIME.

- 9. THE BASE FLOOD ELEVATIONS, FLOODWAY/FLOODPLAIN DELINEATIONS, AND FEMA ZONES WERE DERIVED FROM THE FEMA FLOOD INSURANCE RATE MAP, MAP NUMBER 53037C1254D, DATED SEPTEMBER 24, 2021.
- 10. THE BOUNDARY LINES FOR PARCEL NUMBER 265133 ARE APPROXIMATE. AT THE TIME OF SURVEY NO LEGAL DESCRIPTION FOR SAID PARCEL COULD BE LOCATED. BOUNDARY LINES ARE DRAWN AS APPROXIMATE BASED ON THE KITTITAS COUNTY TAX PARCEL
