Hi Zach--our response to comments regarding SX-24-00001 Baumann follows.

Thank you all for your timely consideration of our proposed SFR. Although the proposed site was previously disturbed during the installation of the existing residential septic system, we understand the probability of an inadvertent discovery. We are sensitive to the need for protection and preservation of cultural resources. As such we have prepared the IDP below and will ensure those disturbing the ground for construction are also sensitive to the protection and preservation of any inadvertent findings.

## **Inadvertent Discovery Plan (IDP)**

Site Name: 10350 Manastash Road Project Lead: Costlo Construction LLC County: Kittitas

This IDP is to be posted in an area accessible to contractors at Kittitas County parcel #615133 during all phases of construction involving ground disturbance of any depth. All contractors involved in ground preparation or disturbance will be required by the project lead to review the Washington Department of Ecology's IDP video (<u>https://www.youtube.com/watch?v=ioX-4cXfbDY</u>) and be briefed on the location of this IDP before beginning work.

Any human skeletal remains, regardless of antiquity or ethnic origin, will at all times be treated with dignity and respect. Follow the steps Stop-Protect-Notify. DO NOT speak with the media, allow photography or disturbance of the remains, or release any information about the discovery on social media. If you are unsure whether the discovery is human bone or not, contact Guy Tasa, PhD, with DHAP at (360)790-1633 for identification and next steps. Do not pick up the discovery.

Upon any potential finding all work shall cease immediately until local authorities, DHAP, and interested tribal representatives have satisfied their investigations or approve of protection measures in place to continue construction.
