The proposed project includes access improvements for future residential development of 8-Lots. The access will be constructed per KCC 12.04.080 within 60-ft easements and turn-arounds per IFC Appendix D for Parcels 952220, 952221, 11574, 11572, 11573, 952222, 952223, 952223. The existing easement access starts at Parke Creek Rd east of Kittitas between Parcels 10831 and 11572. Proposed improvements include grading for width, surfacing, and installing new drainage swales as needed. See attached Site Plan.

Erosion is not anticipated due to the controls that will be in place during the work including a stabilized construction entrance, covering of stockpiles, and silt fence as needed.
