SEPA **DETERMINATION OF NONSIGNIFICANCE**

Public Works Reecer Creek (SE-24-00034)

Description:

A proposed change that would (1) fallow up to 56 acres and (2) transfer the consumptive use portion of the water right to instream flow and mitigation for enrollment in the State's Trust Water Right Program (TWRP). Once the water right is in the TWRP, the Applicant will make the water available through market re-allocation to mitigate out of priority water use. This water right could be allocated through the County's existing mitigation bank or potentially be allocated to an existing Group A Water System through the Kittitas County bank. The subject property is zoned

Light Industrial. The subject properties land use is Urban.
